

**EMMY'S HOPE RESCUE
PET ADOPTION CONTRACT**

____ 1. I/we agree that I/we will never sell trade or give away this pet to anyone. I/we will never relinquish this pet to any shelter or pound, whether "no kill" or otherwise. I/we will notify Emmy's Hope Rescue if I/we are unable or unwilling to keep this pet and I/we will return this pet to them after arrangements have been made for such return. If this pet is lost or stolen, I/we will notify Emmy's Hope Rescue within 24 hours. I/we will keep tags on the dog/cat with current information at all times.

____ 2. I/we agree that all future medical and health maintenance treatments are my/our responsibility, unless Emmy's Hope Rescue has specifically agreed to pay for them under the "special Provisions" at the end of this contract. I/we will administer monthly heartworm preventative to the dog year round. If the dog is heartworm positive, I/we understand that I/we will take the dog to my/our Vet for proper heartworm treatment as recommended by my/our Vet.

____ 3. My/our dog will be primarily indoors, interacting with my/our family and will not be banished to the back yard. I/we never tie my/our dog to a chain or rope or leave him/her unattended for long periods.

____ 4. My/our cat will be kept indoors at all times.

____ 5. I/we will protect this pet with annual vaccinations and routine medical care and health maintenance as recommended by my/our Vet. I/we will seek immediate (at time of injury or signs of illness) veterinary care if this pet becomes ill or is injured. I/we understand this is for the lifetime of the pet.

____ 6. I/we understand that Emmy's Hope Rescue does not make guarantees regarding the age, nature, temperament or health of this pet. I/we assume all risks and responsibility of ownership of this pet once he/she is in my possession. I/we agree to defend, indemnify and hold harmless Emmy's Hope Rescue against any and all claims including claims of property damage and/or personal injury, which may arise from my/our adoption of this pet.

____ 7. If I/we fail to fully and timely comply with the terms of this contract, I/we will, voluntarily and immediately release ownership, possession, custody and control of this pet to Emmy's Hope Rescue, and if I/we fail to do so, then they are entitled to enforce specific performance(s) of this contract in addition to any other legal remedy available to them.

____ 8. I/we affirm that all information in the Application and Contract is true, complete and correct, and agree that any false or misleading statement(s) thereon will constitute a breach of this contract.
